



## Time table - important notes

Dear Athletes,

we look forward to seeing you in Hagen a.T.W. to Horses & Dreams 2026

To make sure that our show in Hagen runs smoothly, please take note of the following directions:

### EHV Prevention (horses)

On arrival, for national horses the **3-day temperature protocol of all horses** must be handed in. For International horses please use the **FEI Horse App**.

Upon arrival, the **3-day temperature** log of the horses, the completed "Check-In Form", for horses competing nationally must be submitted. For horses competing internationally, upload the temperatures in the **FEI Horse App** as well.

**NEW: The vaccination against influenza must also be entered in the horse app**

Temperature checks upon arrival are mandatory **and must be carried out** by the rider/groom **before the horse is put into its assigned stall**, in the presence of the FEI veterinarian or a person authorized by him (you must bring your own thermometer).

From the moment the horse is stabled, it is mandatory to measure fever twice a day (**once before 11.59 am and once between 12.00am and 8.00pm**) and enter this for horses competing internationally in the **FEI Horse App** and for horses competing nationally which must be visibly attached to the box.

### Health Paper

If you need "Health Paper" for your horses, please fill in the form and hand it in to the show office by Thursday 21.04. 9.00 a.m.

Dear all,

as some of your riders will participate in the CDI/ CSI in Hagen a.T.W this week, the local veterinary authorities have ask the organiser to remind you that the horse/horses you are bringing to the event must be registered in TRACES which is EU System for horse transport within the EU.

Please be advised that if your horse/horses are not registered in TRACES you might have trouble to transport the horse back.

Please be so kind and advise your riders accordingly. Thank you very much for your help.
