### Arrival and stabling

### Examination on Arrival and EHV Prevention (horses)

For horses **competing internationally**, upload the temperatures (3-day-temperature) in the **FEI Horse App** as well

**NEW: The vaccination against influenza must also be entered in the horse app**

Temperature checks upon arrival are mandatory **and must be carried out** by the rider/groom **before the horse is put into its assigned stall**, in the presence of the FEI veterinarian or a person authorized by him (you must bring your own thermometer).

From the moment the horse is stabled, it is mandatory to measure fever twice a day (**once before 11.59 am and once between 12.00am and 8.00pm**) and enter this in the **FEI Horse App**

### Parking

If you park your truck/horsebox/trailer (with electricity- you must order electricity until 03.06.26 by mail at [show@reitturnier.de](mailto:show@reitturnier.de)) on the showground you have to pay a parking fee according to the FEI schedule.

**Show office** will be open Tuesday June 9th., 11h00.

### Health Paper

Coming from another country than Germany, you need health papers. State veterinarians will be on site to check this.

### Anti Doping

#### Anti Doping- Human

"Important note for all participants:

All participants in international competitions are subject to the FEI Anti-Doping Rules for Human Athletes (ADRHA). In this context, the FEI or a control agency used by it, the International Testing Agency (ITA), is obliged to take unannounced competition samples from participants. The ITA selects the athletes for the rehearsals itself or conducts them at the suggestion of the FEI. Participants can find out about the process of a doping control on the website [https://youtu.be/Ge6UF7\\_JJqI](https://youtu.be/Ge6UF7_JJqI) with the help of an explanatory film. In the event of controls, we ask the participants to be willing to cooperate accordingly. In order to be well informed which medications and dietary supplements are permitted or permitted in competition. "We recommend downloading the banned app from the National Anti-Doping Agency (NADA) in the app store."
