Due to the recent active strains of virus infections in some countries and stricter biosecurity measurements we would like to advise you to measure and record the temperature of your horse(s) twice daily (morning and evening) at least the last five days prior to arrival at the competition and bring in this record (an example is attached) together with the FEI-passport to the "Examination on Arrival."

The monitoring and recording of the temperatures should be continued each day during the competition and the record visible placed in front of your horsebox in the stables.

Please don't bring in horses from affected areas and horses, that had temperatures over 38.2 °C during the last days!

**If you wish you may arrive from Thursday, 04/10/2018 – 08.00 am.** We thank you for your understanding in case of a delay on arrival!

## General Data Protection Regulation (GDPR)

Collecting the data from riders is for administration purposes and entry procedures in this show, as well as the economic liquidation derived from the mentioned show. As far as processing personal data, we are required to fulfil legal obligations that are subject to our company, whereby Art. 6 (1) lit. c GDPR serves as legal basis.

Additionally, you are kept informed and you allow RI to collect your personal data in the present form. This data can be communicated in accordance to the current normative of the National Equestrian Federations concerned. If you are photographed during this event in a prize giving ceremony or else, the pictures can be published on our website / video big screen or info system.

We may share personal information collected through this entry system with our affiliated organizations and with selected partners (including sponsors of various classes), who may use it to contact you with information. We also share personal information collected through this entry system with third party vendors who act for us or on our behalf, for example other support services. Our affiliates and partners/ subcontractors may also share personal information with vendors who provide support services to them.

In addition, you agree that RI may access, preserve, and disclose your personal information and content given by you in this entry system: (i) if required to do so by law; (ii) to respond to claims that any content you have given in this entry violates the rights of third-parties; (iii) to respond to your requests for assistance; (iv) to protect the rights, property, or personal safety of RI, its users and/or the public; or (v) or in the event of a transfer of ownership of RI, merger, or other similar transaction.
